Since SPM Balongan has 2 mooring hawser, the vessel will be cleared if it has 2 chain stopper.

However for the vessel with only 1 chain stopper, we can berth the vessel by securing one mooring hawser to vessel's only chain Stopper and the other mooring hawser will be secured to bollard (in slack). But both hawser will go through Panama choke.
